

Quarterly Performance Attribution²

The strategy outperformed given our overweight to spread product despite the Treasury curve moves.

- (+) IG Corporates Overweight was additive to performance. Specific subsectors included Wirelines, Electrics, Banking and Healthcare. Midstream slightly detracted from performance.
- (+) ABS Broad outperformance in fixed-rate Autos, Student Loans and Credit Cards.
- (+) CMBS Both agency (multifamily) and non-agency (conduits) securities added to performance
- (+) Taxable municipals on more targeted fiscal stimulus. Airports and essential services providers outperformed.
- (-) Yield Curve steeper yield curve.

Strategy

We are cautiously optimistic about the near-term prospects of the US economy given current fiscal and monetary stimulus measures, vaccination progress and the rebound of corporate earnings. Even though market fundamentals are catching up to valuations we continue to believe that various asset classes within our investable universe are currently fully priced, some at multi decade lows, as if we are already through this pandemic. As a result, we will maintain our "up-in-quality" bias across portfolios and keep some dry powder to redeploy upon a potential spread widening event. Looking forward, we believe the FED will keep short term Treasury rates pegged near zero for the foreseeable future but we also believe that longer maturities out the curve will continue steepen and hence we will deploy a barbell strategy with more floating rate securities where appropriate. In 2021, we believe sector and security selection will be the main drivers in generating any excess returns as we aim to maintain/build our yield advantage relative to our benchmark indices to drive performance.



The STAMP 1-5 Year strategy seeks to generate excess returns over the short duration benchmark through the active management of sector, yield curve, security and duration allocations within the investment grade universe, with a target duration of +/- 20% to the stated benchmark. Beginning July 1, 2016, the STAMP 1-5 Year composite includes all fee-paying portfolios equal to or over \$10 million, managed on a discretionary basis according to the applicable composite strategy except as otherwise excluded herein. Prior to July 1, 2016, the STAMP 1-5 Year composite included all fee-paying portfolios equal to or over \$20 million. The Firm maintains a complete list and description of composites which are available upon request. Policies for valuing portfolios, calculating performance and preparing compliant presentations are available upon request.
