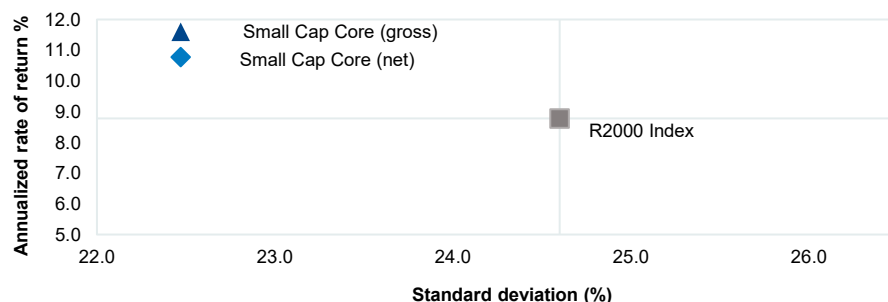
INVESTMENT PHILOSOPHY

We believe the key to generating consistent investment returns is the selection of investment opportunities that possess attractive valuations and demonstrate identifiable catalysts that are expected to generate accelerating earnings and cash flow growth.

INVESTMENT OBJECTIVES¹

Over a full market investment cycle, we strive to generate more than 200 basis points of annualized alpha with approximately 80–90% of the risk of the market, where market risk is defined as standard deviation, beta or downside capture.

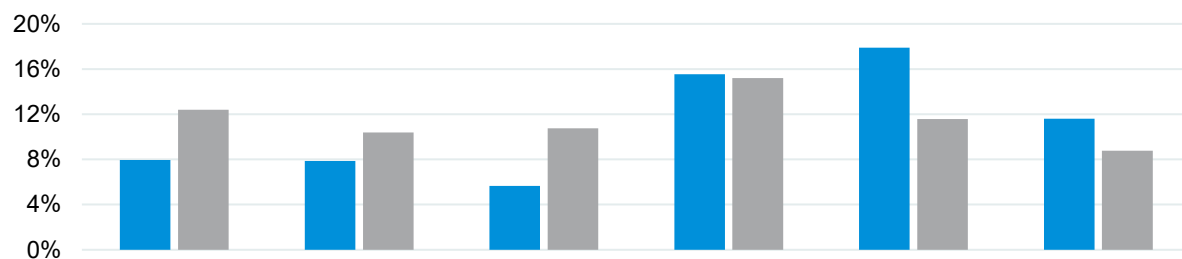

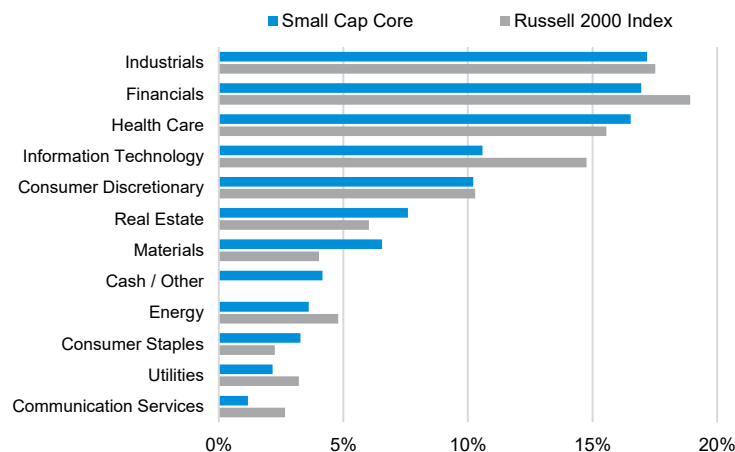

Prior to March 1, 2025, the performance of the composite represents the performance that occurred while members of the management team were affiliated with prior firms. From Inception until June 20, 2022, the composite was part of Mesirow Financial Investment Management (MFIM). From July 1, 2022 until February 28, 2025, the Small Cap Core Equity composite was managed by the investment team while they were affiliated with Mesirow Equity Management ("MEM"). The Small Cap Core Equity composite had been examined for the periods April 1, 2019 to December 31, 2024 while at MFIM and MEM. MEM had been independently verified for the periods January 1, 1996 until December 31, 2024. The verification and performance examination reports are available upon request.

The Small Cap Core Equity Composite represents the small cap core equity portfolios following our relative value based investment philosophy. The strategy seeks selection of investment opportunities that possess attractive valuations and demonstrate identifiable catalysts that are expected to generate positive changes in fundamental metrics. All discretionary institutional accounts are included with no stated minimum account size. Currently, both taxable and non-taxable accounts are included. The Small Cap Core Equity Composite includes all fee-paying portfolios, managed on a discretionary basis according to the applicable composite strategy except as otherwise excluded herein. The Firm maintains a list of composites and descriptions, a list of limited distribution pooled funds and their descriptions, and a list of broad distribution pooled funds, all of which are available upon request. Policies for valuing investments, calculating performance, and preparing GIPS® reports are available upon request.

The investment management fee schedule for the Small Cap Core strategy is 0.85% on the first \$25 million, 0.75% on amounts from \$25 to \$50 million, 0.60% on amounts from \$50 million to \$100 million, and 0.55% on amounts over \$100 million. Net returns have been calculated by reducing the monthly gross returns by the twelfth root of a model fee equal to 0.75%. Investment management fees are described in Part 2A of the Firm's Form ADV.
