- Continuous risk management is done throughout the investment process incorporating but not limited to scenario analysis, portfolio analytics and performance attribution.

We believe active sector rotation across various fixed income markets creates the opportunity to generate excess returns. This multi asset credit strategy seeks to generate high income, excess return performance and attractive risk-adjusted returns by leveraging MetLife Investment Management's global fixed income capabilities to unearth compelling investment ideas.







Net returns have been calculated by reducing the twelfth root of the monthly gross returns by the highest stated ADV fee of the strategy. From inception to November 2008, the highest stated ADV fee used to calculate monthly net returns was 0.40%. From December 2008 to March 2011 the highest stated ADV fee was 0.65%. From April 2011 to the present the highest stated ADV fee is 0.40%.
