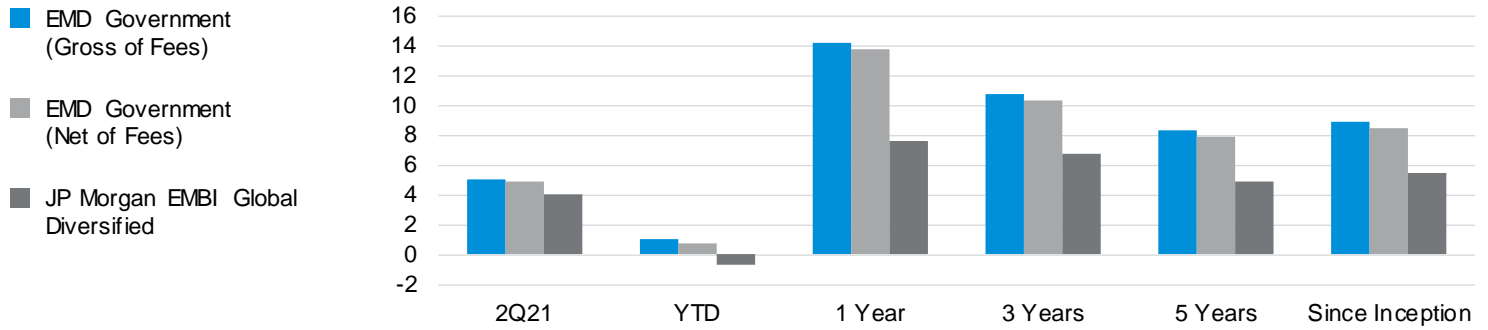
- Focus on security selection, currency selection and country selection as the primary sources of alpha.

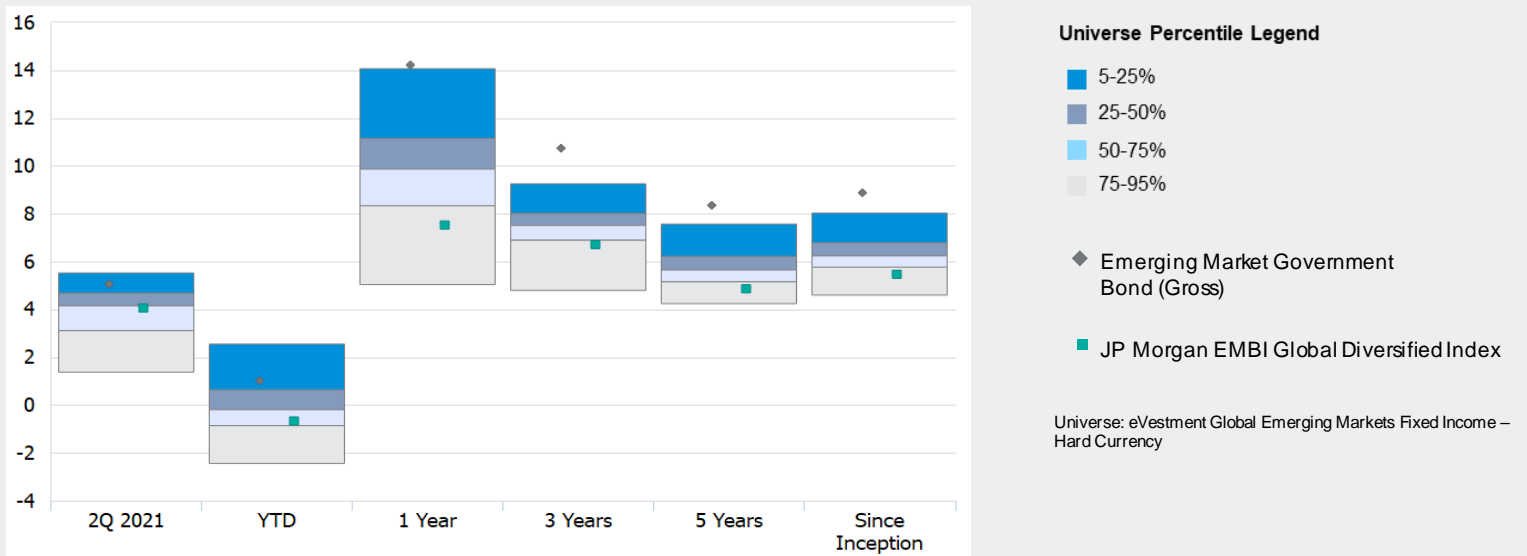

QUARTERLY PERFORMANCE ATTRIBUTION

- The strategy outperformed the index during the second quarter driven by strong security selection and an overweight to high yield securities.
- Exposure in commodity-driven sovereigns contributed given the support from strong commodity prices.
- Managing positioning in LatAm countries through market moving political and IMF stories benefited the portfolio; however, underweights to some high yielding sovereigns that rallied from similar stories detracted from those returns.
- Off-index positioning in basic industry corporates performed well through the commodity space rally.
- Exposure to corporates in the Chinese high yield property space detracted, with the sector under pressure from troubled issuers that have weighed on the space.
- Local exposure positively contributed as the risk-on appetite through May helped most currencies perform well. In addition, the hawkish shift by some central banks boosted currency performance.

STRATEGY

Security selection remains critical in the current environment of idiosyncratic country stories and low yields. We continue to have a constructive view on EM corporates relative to sovereigns given stronger fundamentals and lower volatility. Within the corporate space, we reduced some risk into quarter end, allowing us room to reload into any widening. In the sovereign space, idiosyncratic stories remain an important determinant of positioning. Investment grade countries such as Peru and Chile, as well as high yield names like El Salvador and Angola, remain pockets of opportunity in the market that have seen recent volatility.

Given the changes in the macro backdrop as we transition from a stimulus-heavy recovery to one with moderately tighter liquidity conditions, we remain cautious on non-dollar currency, duration in certain local curves, and more speculative sovereign issuers. With elevated risks of stimulus removal later this year and continued elevated inflation risks, policy decisions and liquidity needs will become more impactful on relative prices.

The Emerging Market Government Bond strategy seeks to generate current income and total return over changing market conditions by investing primarily in US Dollar denominated government and quasi-sovereign bonds domiciled in emerging markets countries, while having limited exposure (up to 30%) to corporate bonds and focusing on country and security selection across the credit spectrum. Derivatives make up a part of the composite strategy and the Firm utilizes futures, forwards and interest rate swaps. The composite includes all portfolios managed on a discretionary basis according to the applicable composite strategy except as otherwise excluded herein. The Firm maintains a complete list and description of composites, which are available upon request. Policies for valuing portfolios, calculating performance and preparing compliant presentations are available upon request.

The performance benchmark for the Emerging Markets Government Bond Composite is the JP Morgan Emerging Markets Bond Index (“EMBI”) Global Diversified Index. The JP Morgan EMBI Global Diversified Index includes US dollar-denominated Brady bonds, Eurobonds, and traded loans issued by sovereign and quasi-sovereign entities. The EMBI Global Diversified Index limits the current face amount allocations of the bonds in the Index and caps the maximum weight of countries at 10%. The Emerging Market Government Bond strategy does not invest in all regions or sectors within the benchmark. It is not possible to invest directly in an unmanaged index. All index returns presented are provided to represent the investment environment existing during the time periods shown and will not be covered by the future report of independent verifiers. The investment management fee schedule for the Emerging Market Government Bond composite is 0.45% on the first \$50 million, 0.40% on amounts from \$50 million to \$150 million and 0.35% on amounts over \$150 million. The highest stated ADV fee is 0.45%.
