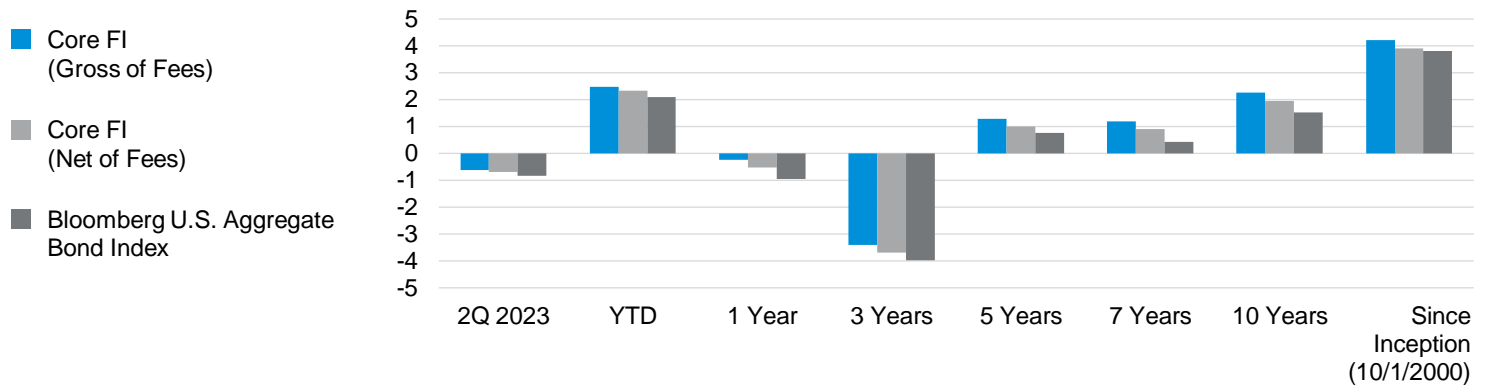
- Methodical portfolio construction seeks to exploit inefficiencies across the curve

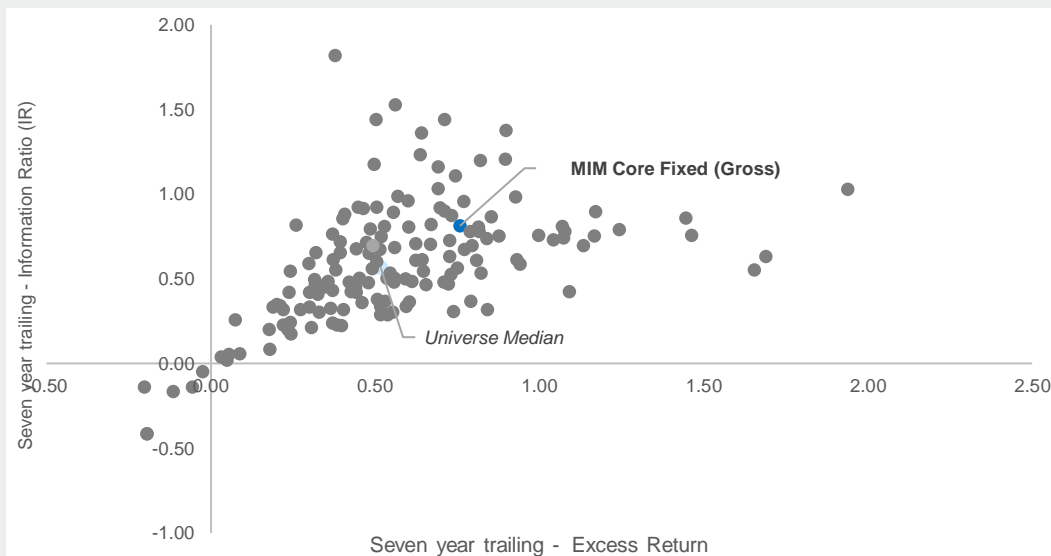

QUARTERLY PERFORMANCE ATTRIBUTION

- During the quarter, security selection was positive as was sector allocation further adding to relative returns. Corporates outperformed the structured assets an underweight to treasuries further added.
- In Investment Grade Financials, relative performance in Banking was positive. Our overweight to the GSIBs and Yankee banks was a boost to performance. Regional banks remained challenged over the quarter.
- Brokerage/Asset Managers/Exchanges as well as Insurance lagged Banking. In Insurance, performance was challenged as sector allocation offset selection. Underweights to large Life Insurance providers, which generated strong return during the period dragged our relative performance.
- Communications outperformed as positioning in Media & Entertainment was a bright spot within the complex. Positive performance was broadly attributed to an issuer whose management team continued to demonstrate a commitment to deleveraging. In Wirelines, an issuer that came under investigation for environmental violations with a potentially costly remediation negatively offset.
- Within Consumer Non-Cyclicals, positioning in Pharmaceuticals and specifically an allocated to a large new issue, contributed favorably. Within Healthcare, exposure to well positioned issuers aided relative performance despite exposure to weaker names as well. Positioning within the Food & Beverage subsector added strong returns as an emerging market issuer differentiated their business model from the broader emerging market risks in addition to a multinational drink and brewing company benefiting from credit ratings upgrades.
- Energy underperformed during the quarter despite positive performance from an issuer within the Independents subsector. Selection partially offset sector weakness.
- In Technology, the underweight supported relative returns. Our overweight to premier technology companies contributed yet weaker exposures partially offset the strength.
- MBS recouped most of the losses from last quarter while adding further gains beyond the rebound. Our overweights supported positive return as did our underweights as well adding to relative performance.
- ABS performance was relatively muted over the quarter as fixed rate securities primarily in autos and consumer credit performed well but were offset by curve positioning.
- CMBS performance detracted despite positive sector allocation led by high-quality holdings outperforming as the sector bounced back from weakness brought on by issues in US banks. SASB Property downgrades detracted from performance and lower quality CMBS struggled to keep pace with higher quality AAA Fixed & Floating Rate CMBS.
- CLO exposure was also additive over the quarter as high-quality spreads grinded tighter over the quarter.

STRATEGY

We continue with a theme from last quarter in pursuing opportunities with respect to upgrading portfolio quality. Specific to corporates, we prefer rotational trades within portfolios to sectors that are better positioned for an economic slowdown. For instance, Utilities, Pharmaceuticals, and Healthcare all continue to see above average issuance, and have presented compelling opportunities to rotate out of more cyclical sectors like Chemicals and Midstream. Even if we continue to be wrong about the timing of a slowdown, we are hard pressed to envision a scenario in which we miss out on a significant spread rally as we maintain an elevated allocation to treasuries. We also expect to maintain our bias to up-in-quality in Asset-Backed Securities (ABS) and more specifically, sub-sectors such as auto related lending and credit cards while reducing exposures to esoteric complexes. Acknowledging that each environment is different, we do believe the inverted yield curve offers a compelling opportunity to favor front end credit. We also are inclined to take advantage of bids for less liquid holdings, as we prefer to give liquidity at more attractive valuations. Yield, in our view, remains a powerful tool in the market that we will use to our advantage to clip coupons as we wait for more attractive opportunities across credit. While solid carry and positive security selection are dependable tools by which to generate alpha, we would welcome a back-up in spreads which would provide a far more robust opportunity set.

Following the most recent quarter of positive performance, Agency MBS in our view, still remains attractive. We believe this asset class warrants an overweight both on an outright basis and relative to corporate bonds. Our overweight is skewed away from the non-production coupons. Given our preference for quality heading into the third quarter, we favor conventional 30-year MBS on better valuations and ultimately, liquidity, should we have an opportunity to act on a spread widening event. Nonetheless, the prospects for large scale spread compression is low in the near term, with carry being the dominant contributor to returns relative to the benchmark.

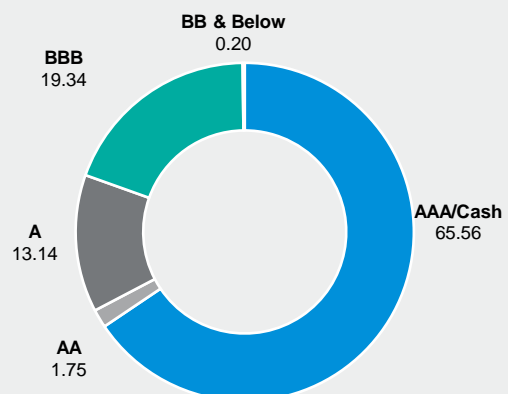

The composite has been examined for the periods November 1, 2007 to June 30, 2019, while at another firm. The prior firm, LCP, was verified for the periods November 1, 2007 to June 30, 2019. The Core strategy seeks to produce risk adjusted long-term total returns above the broad bond market by investing in a core of high-quality U.S. fixed income securities across the government, corporate and structured markets. The Core Fixed Income Composite includes all fee-paying portfolios managed on a discretionary basis according to the applicable composite strategy except as otherwise excluded herein. The account would be reinstated to the composite once the portfolio manager determined the flow had not impacted the management of the account and the account was invested per the strategy.
