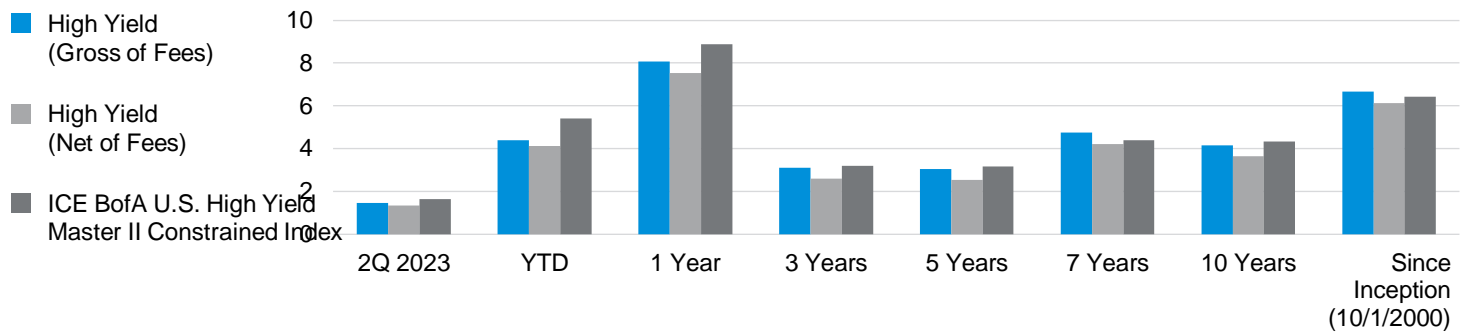
- Portfolios are constructed from the bottom up, with a focus on relative value regardless of sector

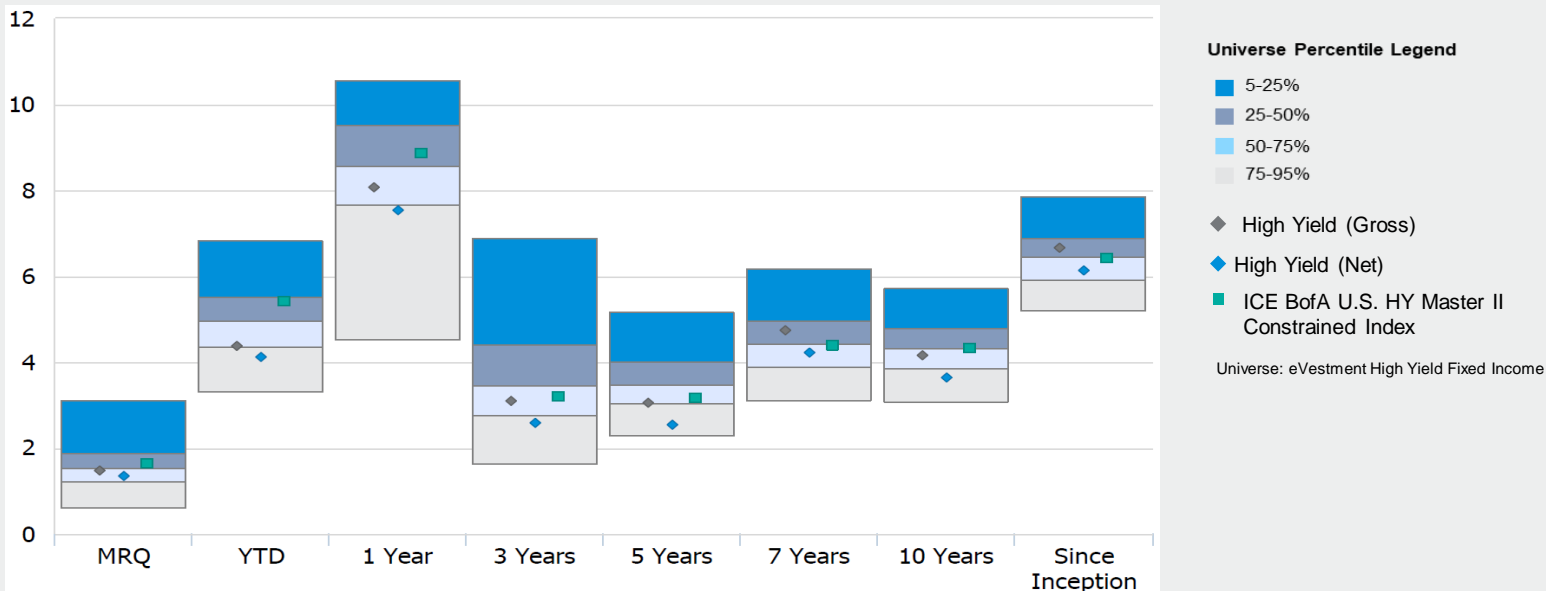

## QUARTERLY PERFORMANCE ATTRIBUTION

- In the telecom space, a certain issuer outperformed as the company bought back bonds at discounted levels and reaffirmed full year guidance for both revenue and EBITDA.
- A certain REIT contributed to performance during the quarter as the company bought back bonds in the open market at lower levels.
- Within financial services, one company weighed on performance after an activist firm released a short selling piece that targeted the company.
- In the building materials sector, one issuer's bonds traded up during the quarter after the company reported in-line earnings and continued to buy back bonds below par.
- A cruise line company was a top performer in the second quarter as the risk-on tone in the market supported positive sentiment in the cruise industry. The industry as a whole reported quarterly results that showed continued positive demand for the cruising product and continued strength in pricing overall.
- A media content company underperformed as the company reported quarterly earnings that showed -300k of net streaming subscriber losses as they cut marketing costs and shifted their focus to "higher-value" customers.
- A tech hardware and equipment company underperformed after the company pre-announced weaker than expected earnings on July 14 before its actual earnings release on July 20 reflecting concerns about cyclical pressure in telecom equipment that materialized during the second quarter.
- A certain cable & satellite company detracted performance after the company reported a modestly weaker-than-expected quarter in early May.
- The portfolio's cash position contributed to performance.

## STRATEGY

While high yield (HY) spreads are inside their long-term average as of 6/30/2023, we maintain a cautiously optimistic view on the asset class due to attractive relative yields and the defensive fundamental positioning of HY issuers. Macro headwinds are beginning to ease, yet uncertainty surrounding economic growth and a projected rise in defaults means detailed security selection will remain crucial in coming quarters. Of note, leveraged credit has historically outperformed following a pause in the Fed hiking cycle. On average, HY assets returned 12.30% in the twelve months following a pause in fed hikes since 1995, while spreads tightened by 26 basis points (Source: JPM). With the yield on the index at an elevated level we see a path for HY to potentially outperform during the second half of the year, driven by coupon-carry in a soft-landing scenario. We also believe that a positive technical and decreased chance of a near-term recession following consecutive cooler-than-anticipated CPI prints should be supportive of HY credit.

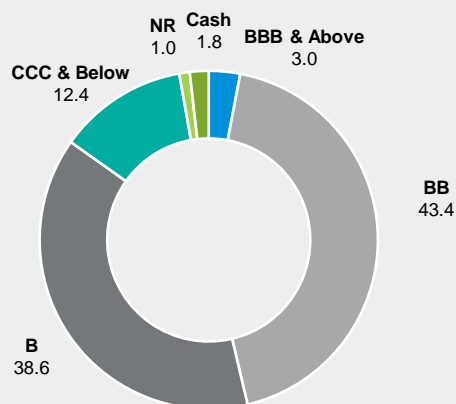

The creation date of the High Yield Composite is November 1, 2007 and the inception date is October 1, 2000. Prior to July 1, 2019, the performance of the composite represents the performance that occurred while members of the management team were affiliated with prior firms. The composite has been examined for the periods November 1, 2007 to June 30, 2019 while at another firm. The prior firm, LCP, was verified for the periods November 1, 2007 to June 30, 2019. The verification and performance examination reports are available upon request.

The High Yield strategy seeks to produce predictable and consistent excess returns relative to a benchmark with a similar level of volatility by investing primarily in U.S. corporate fixed income securities rated below investment grade. In the instance that any of the three major rating agencies has a different quality rating for an individual security, the Firm calculates security quality ratings by using "average" language. Effective March 1, 2014, the High Yield Composite includes all fee-paying portfolios with assets in excess of \$15 million, managed on a discretionary basis according to the applicable composite strategy except as otherwise excluded herein. Prior to March 1, 2014, there was no minimum account size for the High Yield Composite. The Firm maintains a list of composites and descriptions, a list of limited distribution pooled funds and their descriptions, and a list of broad distribution pooled funds, all of which are available upon request. Policies for valuing investments, calculating performance, and preparing GIPS® reports are available upon request.

Since May 1, 2020, there is no significant cash flow policy for this composite. From November 1, 2007 until April 30, 2020, the High Yield Composite had a significant cash flow policy which was applied consistently and within GIPS® standards. The Firm chose to remove accounts that had a significant daily external aggregate cash flow greater than 20% or monthly flow greater than 50%. If any account met these thresholds, then the account was removed from the composite. Aggregate cash flow is defined as additions plus withdrawals over the period. Accounts were removed in the month of the significant cash flow. If the significant cash flow was client-directed requiring security liquidation that materially affected account management, the Firm removed the account the month of security liquidations. The account was reinstated to the composite once the portfolio manager had determined that the flow had not impacted the management of the account and the account was invested as per the strategy. Additional information regarding the treatment of significant cash flows is available upon request.

Effective November 1, 2007, the performance benchmark for the High Yield Composite is the ICE Bank of America Merrill Lynch U.S. High Yield Master II Constrained Index. The ICE Bank of America Merrill Lynch U.S. High Yield Master II Constrained Index is constructed to mirror the high yield debt market. This index includes U.S. dollar publicly issued corporate bonds and deferred interest bonds that are not yet accruing a coupon. Bonds rated in default, or that are not rated are excluded from the index. The ICE Bank of America Merrill Lynch U.S. High Yield Master II Constrained Index is provided to represent the investment environment existing during the time periods shown. From inception of the composite to October 31, 2007, the benchmark was the Bear Stearns High Yield Index. This change was made due to the ICE Bank of America Merrill Lynch benchmark being the more widely used index for institutional investors. The Bear Stearns High Yield Index included fixed rate, non-convertible, U.S. dollar-denominated securities rated both BB+ and Ba1 or lower with an outstanding par value of at least \$100 million. The High Yield Custom Index represents a blend of these two indices during their respective periods as benchmarks for the composite. It is impossible to invest directly in an unmanaged index. All index returns presented are provided to represent the investment environment existing during the time periods shown and will not be covered by the future report of independent verifiers. For comparison purposes, the index is fully invested and includes the reinvestment of income. The returns for the index do not include any transaction costs, management fees, or other costs.

Returns are based on fully discretionary accounts under management and may include terminated accounts. The dispersion of annual returns is measured by the standard deviation among asset-weighted gross-of-fee portfolio returns represented within the composite for the full year. Dispersion is not calculated for composites with five or fewer accounts for the whole period.

Performance returns are presented gross and net-of-fees, include the reinvestment of all income and are calculated in U.S. dollars. Dividend income has been recorded net of all applicable foreign withholding taxes. Net returns have been calculated by reducing the monthly gross returns by a model fee equal to the highest stated ADV fee for the strategy. The investment management fee schedule for the High Yield strategy is 0.50% on the first \$50 million, 0.45% on amounts from \$50 million to \$100 million, and 0.40% on amounts over \$100 million. Net returns have been calculated by reducing the monthly gross returns by the twelfth root of the highest stated ADV fee of 0.50%.
