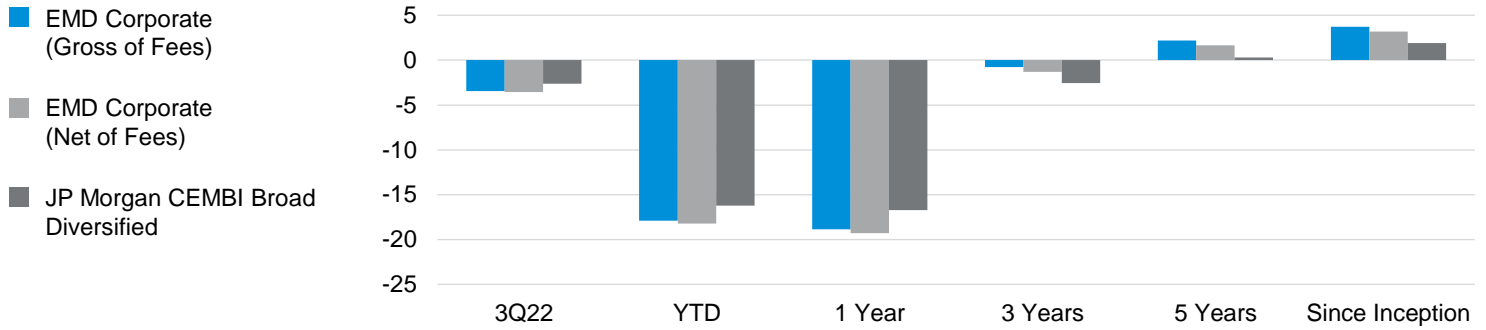
- Focus on security selection, currency selection and country selection as the primary sources of alpha.

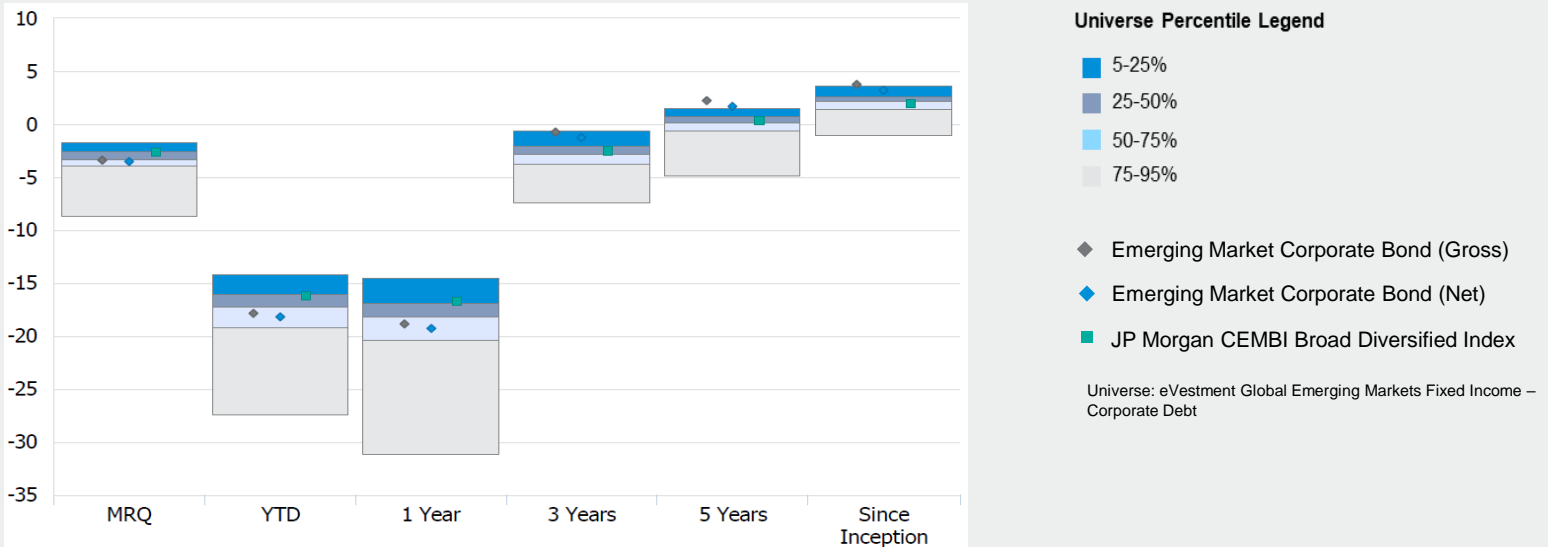

QUARTERLY PERFORMANCE ATTRIBUTION

- The strategy underperformed in the third quarter, weighed down by security selection in the China property space.
- Overweights to duration sensitive Indonesian names detracted as rates continued to rise.
- Exposure to Colombian names detracted with higher funding costs in Colombia and interest rate caps for consumer lending weighing on profitability.
- A Brazilian company detracted after a dispute was opened against the company in relation to the closing price adjusted by the purchase of the company's mobile business.
- An underweight to Turkey, specifically the Financial sector, lessened returns as Turkish banks have been broadly resilient despite the country's considerable macro pressures and abrupt regulatory change.
- Positively offsetting some negative contributors, exposure to Oil & Gas issuers in Israel positively contributed with energy remaining at comfortable levels.
- Overweights to higher beta issuers benefited the portfolio given less duration sensitivity.
- Underweights to higher quality Asian issuers in Singapore, Hong Kong, and South Korea also supported returns as high yield securities outperformed for much of the quarter.
- Off-index exposure to Angola following the reappointment of market friendly president Lourenco benefited returns.
- A Russian oil company's bonds rallied following the announced bond buyback from non-US holders and was further supported as US holders negotiated a higher price with the company.
- The portfolio's elevated cash level continued to be a positive as treasuries sold-off.

STRATEGY

Investing in EM in the current environment remains challenging, aggravated by limited liquidity and a hawkish Fed. Macro factors led by the Russia/Ukraine War, global inflation, and China growth are driving recent risk-off appetite, steering asset valuations, and overshadowing EM fundamentals. These macro headwinds are significant for assets; however, the buffers across many EM corporates and sovereigns are substantial and underrealized. Corporates have priced in downside risk but remain hostage to elevated sovereign spread levels that are weighed down by global factors. As we begin to see clarity on the macro side, we expect stability in spreads and a repricing to better reflect fundamentals, supporting the overall EM asset class and risk appetite.

Security selection has proven to be more important than ever in identifying issuers with strong fundamentals despite a sell-off due to market technicals. We believe this current environment presents opportunities for EM securities, where yields on the indices are at levels not seen since 2009. With double digit negative performance YTD, this weakness could drive performance over the next year horizon.

The Emerging Market Corporate Bond strategy seeks to generate current income and total return over changing market conditions by investing primarily in US Dollar denominated emerging markets domiciled corporate bonds, while having limited exposure (up to 30%) to emerging market government issues and wholly owned government entities and focusing on country and security selection across the credit spectrum. Derivatives make up a part of the composite strategy and the Firm utilizes futures, forwards and interest rate swaps. Effective March 1, 2021 the Emerging Market Corporate Bond composite contains fully discretionary, fee-paying fixed income accounts with assets exceeding \$50 million, managed in accordance with the applicable composite strategy except as otherwise excluded herein. Prior to March 1, 2021 there was no minimum account size for the Emerging Market Corporate Bond composite. The composite includes all portfolios managed on a discretionary basis according to the applicable composite strategy except as otherwise excluded herein. The Firm maintains a list of composites and descriptions, a list of limited distribution pooled funds and their descriptions, and a list of broad distribution pooled funds, all of which are available upon request. From inception date to June 30, 2019, the highest fee used to calculate monthly net returns was 0.55%. From July 1, 2019 to the present the highest stated ADV fee is 0.50%. Investment management fees are described in Part 2A of the Firm's Form ADV. 100% of the composite assets are comprised of non-fee-paying portfolios for the periods presented.
