
- Focus on security selection, currency selection and country selection as the primary sources of alpha.



QUARTERLY PERFORMANCE ATTRIBUTION

- The strategy outperformed the benchmark during the third quarter, driven by security selection across regions, high yield positioning, and off-index corporate exposure.
- The portfolio's cash level continued to benefit the portfolio as treasuries sold-off.
- Overweights to high yield sovereigns that are seeking support from the IMF such as El Salvador and Kenya positively contributed.
- An overweight to Angola benefited returns, as well as an underweight to Pakistan.
- In Mexico, an electric company was a top performer following a positive earnings report, in addition to exiting the position prior to weakness in September as caution grew around upcoming challenges for the company.
- Russia sovereign exposure positively contributed as the bonds were repriced higher during the quarter amid small trade activity.
- Oil and Gas BB corporate exposure performed well as energy remains at comfortable levels for EM exporters.
- A Chilean wireless company announced a tender following a sale of tower assets, positively supporting bond prices.
- Long duration BBB securities were weighed down by the sharp rise in US treasury yields during the quarter.
- As a result, exposure to long sovereign and quasi-sovereign bonds in Panama, Kazakhstan, and Saudi Arabia partially offset some positive performance.
- Hungary and Romania local currency exposure weighed on returns as Europe continues facing a looming energy crisis and recession fears.

STRATEGY

Investing in EM in the current environment remains challenging, aggravated by limited liquidity and a hawkish Fed. Macro factors led by the Russia/Ukraine War, global inflation, and China growth are driving recent risk-off appetite, steering asset valuations, and overshadowing EM fundamentals. These macro headwinds are significant for assets; however, the buffers across many EM corporates and sovereigns are substantial and underrealized. Corporates have priced in downside risk but remain hostage to elevated sovereign spread levels that are weighed down by global factors. As we begin to see clarity on the macro side, we expect stability in spreads and a repricing to better reflect fundamentals, supporting the overall EM asset class and risk appetite.

Security selection has proven to be more important than ever in identifying issuers with strong fundamentals despite a sell-off due to market technicals. We believe this current environment presents opportunities for EM securities, where yields on the indices are at levels not seen since 2009. With double digit negative performance YTD, this weakness could drive performance over the next year horizon.

The Emerging Market Government Bond strategy seeks to generate current income and total return over changing market conditions by investing primarily in US Dollar denominated government and quasi-sovereign bonds domiciled in emerging markets countries, while having limited exposure (up to 30%) to corporate bonds and focusing on country and security selection across the credit spectrum. Derivatives make up a part of the composite strategy and the Firm utilizes futures, forwards and interest rate swaps. Effective March 1, 2021 the Emerging Market Government Bond composite contains fully discretionary, fee-paying fixed income accounts with assets exceeding \$50 million, managed in accordance with the applicable composite strategy except as otherwise excluded herein. Prior to March 1, 2021 there was no minimum account size for the Emerging Market Government Bond composite. The composite includes all portfolios managed on a discretionary basis according to the applicable composite strategy except as otherwise excluded herein. The Firm maintains a list of composites and descriptions, a list of limited distribution pooled funds and their descriptions, and a list of broad distribution pooled funds, all of which are available upon request. Policies for valuing investments, calculating performance and preparing GIPS reports are available upon request.
