
- Portfolios are constructed from the bottom up, with a focus on relative value regardless of sector



QUARTERLY PERFORMANCE ATTRIBUTION

The bank loan strategy outperformed on the quarter almost exclusively due to detailed security selection from our research team. A certain industrial equipment name was a large contributor to performance following a significant change at the managerial level, while some of our retail holdings outperformed on the quarter due to strong second quarter earnings. We had a few energy names that reported challenged second quarter results, but regardless these bonds still managed to perform in sympathy with increases in natural gas and LNG prices. We realized underperformance in the telecommunications sector after uncertainty surrounding future operations for some of our names. Further outperformance in the portfolio was held back by our overweight cash position.

STRATEGY

We believe the long-term recovery of the leveraged loan market, and broader risk assets, is supported by robust global growth, improving earnings fundamentals, and continued vaccine dissemination. We continue to believe the short-term will be defined by pockets of volatility amid this ongoing recovery trend. The receptiveness to vaccination by the broader population along with ebbs and flows in variant-cases challenge the path to herd immunity and may ultimately lead to COVID-19 becoming more endemic. Furthermore, inflationary pressure and inflections in rates will likely continue to take center stage as the specter of Fed tapering and interest rate hikes becomes more realistic. We are also focused on news of global supply chain disruptions and the impact these can have on input costs and the flow of goods.

Accordingly, we continue to maintain a mildly cautious approach as pandemic-related impacts continue to challenge improvements in underlying company fundamentals. Furthermore, record setting investor demand and issuer-friendly conditions have led to heightened valuations for certain issuers. We will maintain our efforts on identifying credits we feel will provide the best relative value opportunities to drive performance. We believe interest rates will continue to be volatile in the face of persistent inflation threats. Prospects for higher rates will likely continue to put the floating-rate asset class in focus and should support investor demand. We believe the supportive market conditions will continue to lead to a robust primary market, positive momentum in rating migration, and benign default rates. Accordingly, we will selectively participate in the primary market, identifying issuers we feel have solid fundamentals and adding to existing higher conviction holdings. We are beginning to see the LIBOR transition take shape with nearly all new primary LIBOR based deals containing documentation mechanisms to move to an alternative base rate once LIBOR goes away. We have recently seen the launch of several SOFR based loans in the market and expect more to follow.



The composite has been examined for the periods January 1, 2014 to June 30, 2019 while at another firm. The prior firm, LCP, was verified for the periods November 1, 2007 to June 30, 2019. The Bank Loan strategy seeks to produce predictable and consistent excess returns relative to a benchmark with a similar level of volatility by investing primarily in U.S. leveraged loans, senior secured debt and senior unsecured debt rated below investment grade. In the instance that any of the three major rating agencies has a different quality rating for an individual security, the Firm calculates security quality ratings by using "average" language. Effective March 1, 2021 the Bank Loan Fixed Income composite contains fully discretionary, fee-paying fixed income accounts with assets exceeding \$25 million, managed in accordance with the applicable composite strategy except as otherwise excluded herein. From July 1, 2016, the Bank Loan composite does not have a minimum account size. Prior to July 1, 2016, the minimum account size was \$15 million.
