

QUARTERLY PERFORMANCE ATTRIBUTION

- The portfolio's outperformance was primarily driven by detailed security selection during the quarter.
- In the Cable and Satellite space, one issuer contributed to performance after announcing an all-stock merger with another satellite company. The transaction is expected to enhance financial flexibility and liquidity to support wireless funding needs. Another Cable & Satellite company outperformed as it reported better-than-expected earnings that were driven by net subscriber losses that were better than estimates.
- A Consumer Services company outperformed after it affirmed full year operating income guidance towards the high end of its previously provided range and reported digital subscribers that grew quarter-over-quarter.
- Within the Telecommunications sector, positive performance in one issuer due to the announcement of a new contractor for its LEO satellites was offset by weakness in another company after it received a ratings downgrade across its capital structure.
- A Media Content company underperformed after it put out a press release that the company would not be paying the scheduled coupon on its 2nd Lien Notes due October 1st and would enter into a 30-day grace period.
- A certain Tech Hardware and Equipment issuer weighed on performance due to earnings that reflected weak carrier capex spending in North America as accelerated 5G spending has been completed.
- The portfolio's overweight exposure to Oil Field and Equipment services contributed to performance as the sector outperformed due to elevated oil prices.

STRATEGY

In the high yield (HY) asset class that has historically had low correlation with interest rates, macroeconomic factors will play a significant role in returns, especially for the longer-duration BB-rated cohort. Interest rates and the probability of a recession will likely remain the primary drivers of risk for HY in coming quarters as the Fed navigates through what many formerly thought would be the end of the rate-hiking cycle. As the market continues to digest the "higher for longer" narrative, issuers will face more expensive coupons and thus must be strategic on the timing of their refinancings-- is it better to refinance sooner than later in case of further rate hikes, or to remain patient in hopes that the Fed begins to cut quicker than expected? We remain cautious on issuers with higher allocations to floating-rate exposure due to these higher interest burdens. While bond prices in energy-related sectors should benefit from higher oil prices, companies who rely on energy as an input may realize margin pressures. We will keep a close eye on hedging strategies and pass-through mechanisms to assess vulnerability to commodity exposure for issuers in at-risk sectors. As always, detailed security selection remains crucial in this environment. With the average yield hovering around 9%, we believe the asset class could begin to see inflows, especially once treasury rates stabilize.



The creation date of the High Yield Composite is November 1, 2007 and the inception date is October 1, 2000. Prior to July 1, 2019, the performance of the composite represents the performance that occurred while members of the management team were affiliated with prior firms. The composite has been examined for the periods November 1, 2007 to June 30, 2019 while at another firm. The prior firm, LCP, was verified for the periods November 1, 2007 to June 30, 2019. The verification and performance examination reports are available upon request.

The High Yield strategy seeks to produce predictable and consistent excess returns relative to a benchmark with a similar level of volatility by investing primarily in U.S. corporate fixed income securities rated below investment grade. In the instance that any of the three major rating agencies has a different quality rating for an individual security, the Firm calculates security quality ratings by using "average" language. Effective March 1, 2014, the High Yield Composite includes all fee-paying portfolios with assets in excess of \$15 million, managed on a discretionary basis according to the applicable composite strategy except as otherwise excluded herein. Prior to March 1, 2014, there was no minimum account size for the High Yield Composite. The Firm maintains a list of composites and descriptions, a list of limited distribution pooled funds and their descriptions, and a list of broad distribution pooled funds, all of which are available upon request. Policies for valuing investments, calculating performance, and preparing GIPS® reports are available upon request.

Since May 1, 2020, there is no significant cash flow policy for this composite. From November 1, 2007 until April 30, 2020, the High Yield Composite had a significant cash flow policy which was applied consistently and within GIPS® standards. The Firm chose to remove accounts that had a significant daily external aggregate cæh flow greater than 20% or monthly flow greater than 50%. If any account met these thresholds, then the account was removed from the composite. Aggregate cash flow is defined as additions plus withdrawas over the period. Accounts were removed in the month of the significant cash flow was client-directed requiring security liquidation that materially affected account management, the Firm removed the account the month of security liquidations. The account was reinstated to the composite once the portfolio manager had determined that the flow had not impacted the management of the account was invested as per the strategy. Returns are based on fully discretionary accounts under management and may include terminated accounts. The dispersion of annual returns is measured by the standard deviation among asset-weighted gross-of-fee portfolio returns represented within the composite for the full year.
