
- Focus on security selection, currency selection and country selection as the primary sources of alpha.



QUARTERLY PERFORMANCE ATTRIBUTION

The EM Sovereign strategy underperformed the benchmark during the fourth quarter. Positioning in Modern Land was the largest detractor as the China property space continues to struggle with finding short term funding options for their capital needs. Exposure to quasi-sovereigns and corporates in lieu of sovereigns detracted as sovereigns outperformed during the period. This was most notable in the investment grade space, including Indonesia, Peru, and Panama. Additionally, exposure to high yield names such as El Salvador, Ghana, and Egypt weighed on returns as risk-off sentiment returned to the market in November, driven by fears of slowing global growth and Omicron lockdowns, and bonds were not able to fully reverse losses during the December strength. Turkish corporate exposure detracted, weighed down by the country's high inflation and weakening lira.

To offset some of these detractors, underweight exposure to Sri Lanka contributed as default lingers and proactive IMF support is questionable. Pemex contributed after the quasi-sovereign announced a liability management transaction supported by a \$3.5bn capitalization from the government. Being underweight Russia benefited the portfolio given ongoing geopolitical pressures. Given negative market sentiment, security selection within high quality countries including Kazakhstan and Qatar contributed positively to performance. Off-index exposure to Aramco bonds performed well after the oil giant reported a surge in profits due to high oil prices and volumes. Peru local exposure saw a nice rally to start the quarter following a cabinet shuffle and reappointment of the Central Bank governor pointing towards more political moderation than initial expected under Castillo.

STRATEGY

The EM Sovereign strategy underperformed the benchmark during the fourth quarter. Positioning in the China property sector underperformed, as the space continues to struggle with finding short term funding options for their capital needs. Exposure to quasi-sovereigns and corporates in lieu of sovereigns detracted as sovereigns outperformed during the period. This was most notable through investment grade countries. Additionally, exposure to high yield names weighed on returns as risk-off sentiment returned to the market in November, driven by fears of slowing global growth and Omicron lockdowns, and bonds were not able to fully reverse losses during the December strength. Turkish corporate exposure detracted, weighed down by the country's high inflation and weakening lira.

To offset some of these detractors, underweight exposure to a high beta Asian country contributed as default lingers and proactive IMF support is questionable. Returns were also supported after a quasi-sovereign holding announced a liability management transaction supported by capitalization from the government. Underweight exposure to Eastern European countries underperformed as the countries face pressure with the building Russia/Ukraine conflict. Given negative market sentiment, security selection within investment grade countries contributed positively to performance. Select off-index local exposure in Latin America saw a nice rally to start the quarter following political shuffles pointing towards more moderation than initially expected under the new regime.

The Emerging Market Government Bond strategy seeks to generate current income and total return over changing market conditions by investing primarily in US Dollar denominated government and quasi-sovereign bonds domiciled in emerging markets countries, while having limited exposure (up to 30%) to corporate bonds and focusing on country and security selection across the credit spectrum. Derivatives make up a part of the composite strategy and the Firm utilizes futures, forwards and interest rate swaps. Effective March 1, 2021 the Emerging Market Government Bond composite contains fully discretionary, fee-paying fixed income accounts with assets exceeding \$50 million, managed in accordance with the applicable composite strategy except as otherwise excluded herein. Prior to March 21, 2021 there was no minimum account size for the Emerging Market Government Bond composite. The composite includes all portfolios managed on a discretionary basis according to the applicable composite strategy except as otherwise excluded herein. The Firm maintains a complete list and description of composites, which are available upon request. Policies for valuing portfolios, calculating performance and preparing compliant presentations are available upon request.
